SUMMARY JURISDICTION NOTICE

To: Plateau United FC

Date: 11th November 2024

1. You are in breach of **Rule B13.52 of the Frameworks and Rules of the Nigeria Premier Football League**, in that on Sunday, 10 November 2024, in the course of Match Day 11 Fixture: Plateau United v Rangers Int'l, you failed to provide adequate and effective security which resulted in attacks against match officials and the visiting team by your supporters.
2. You are in breach of **Rule B13.18 of the Frameworks and Rules of the Nigeria Premier Football League**, in that on Sunday, 10 November 2024, in the course of Match Day 11 Fixture: Plateau United v Rangers Int'l, your supporters threw objects towards the field of play resulting in injury to a match official.
3. You are in breach of **Rule C9 of the Frameworks and Rules of the Nigeria Premier Football League**, in that on Sunday, 10 November 2024, in the course of Match Day 11 Fixture: Plateau United v Rangers Int'l, you failed to ensure the proper conduct of your supporters.
4. You are in breach of **Rule C11 of the Frameworks and Rules of the Nigeria Premier Football League**, in that on Sunday, 10 November 2024, in the course of Match Day 11 Fixture: Plateau United v Rangers Int'l, your supporters attacked a match official after the game.
5. You are in breach of **Rule C1.1 of the Frameworks and Rules of the Nigeria Premier Football League**, in that on Sunday, 10 November 2024, in the course of Match Day 11 Fixture: Plateau United v Rangers Int'l, for conduct capable of bringing the game to disrepute.

Consequently, the NPFL hereby impose on you the following sanctions:

- a) **A fine** of One Million Naira only (N1,000,000) for failure to provide adequate and effect security.
- b) **A fine** of One Million Naira only (N1,000,000) for throwing of objects.
- c) **A fine** of One Million Naira only (N1,000,000) for failing to ensure the proper conduct of your supporters.
- d) **A fine** of Five Hundred Thousand Naira only (N500,000), being compensatory payment of Two Hundred and Fifty Thousand Naira (N250,000) each, to *Zakari Aminu (Reserve Referee) and Daniel Onyia (Rangers Player)*.


- E. A fine** of One Million Naira only (N1,000,000) for misconduct capable of bringing the game to disrepute.
- F. An order** deducting 3 points and 3 goals from the accrued points/goals of Plateau United for assault on a match official.
- G. An order** closing the New Jos Stadium to fans for the next three home matches.
- H. An order** for Plateau United to underwrite the cost of repairing the damaged team bus of Rangers Int'l FC, and other verifiable loss suffered or cost incurred

In accordance with **Rule C26**, you are required, within 48 hours of the date of this notice, to either:

- 1) submit to the summary jurisdiction and the sanctions contained herein;
or
- 2) elect to be dealt with by a disciplinary panel.

Any such election must be in writing addressed to the undersigned at the office of the NPFL. Should you submit to the summary jurisdiction and the prescribed sanctions, kindly note that the fines therein are to be paid within 7 working days.

Note that in accordance with Rule E1, where an appeal or election to be dealt with by a disciplinary panel fails or is found to have been frivolous, such party may be liable to such additional sanction(s) as may be deemed fit in the circumstances.
